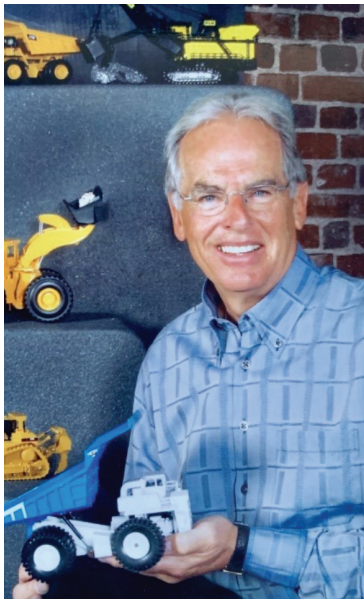




THE CIM FOUNDATION PARTICIPATES IN THE AME ROUNDUP AGAIN THIS YEAR!

For a second year in a row, the CIM Foundation was present at the AME Roundup conference at the Vancouver Convention Centre in January. President Tom Broddy, FCIM, with support from Zoltan Lukacs, FCIM, and CIMF Indigenous Endowment donor Alex Davidson, FCIM, greeted convention delegates and provided information about the Foundation's activities, programs, scholarships and grants

THE JIM POPOWICH MEMORIAL MINING ENDOWMENT FOR THE BENEFIT OF STUDENTS AND MINING PROFESSIONALS IN CANADA



Jim Popowich, FCIM, was always a special supporter of the CIM Foundation. He particularly liked to spread the word about the importance of minerals, and the mineral cards project increased to more than 750 copyright-free cards thanks to his generous support (www.cimfoundation.ca). The cards continue to be used by educators and students for school projects. Additionally, the mineral playing cards were created by special request from Jim.

Laverne Popowich has established a generous endowment in memory of her husband. Their endowment will support, in perpetuity, undergraduate Geology students pursuing a degree.

Thanks to this endowment, this fall the CIM Foundation will offer certificates in Health and Safety programs in their provinces. The endowment also provides grants to support mining professionals who wish to secure a certificate in Health and Safety, as well as for those looking to upgrade their skills in new technologies and innovation.

These scholarships and grants are available to Canadian students and to mining professionals working in Canada and will be offered in perpetuity.

The new scholarships and grants will be as follows:

- 1 x \$3,000 scholarship for a third-year student in a Geology program
- 2 x \$750 grant for a student for a Health and Safety Certificate program which is usually a three-day program for students in their third or fourth year
- 2 x \$750 grant for a mining professional for a Health and Safety Certificate program which is usually a three-day program, open to professionals with more than five years of experience in the mining industry
- 1 x \$3,000 grant for a mining professional for a specialized course in technologies that will provide the professional with additional competencies to enhance his or her qualifications, open to professionals with more than five years of experience in the mining industry

THE RENO PRESSACCO, P.GEO., SCHOLARSHIP FOR GEOLOGY STUDENTS



Through a special gift, Reno Pressacco, P.Geo., has established a Geology scholarship for third-year undergraduate students. He created this scholarship because of his experience as a young student mentored by the late Dr. David Robertson. Dr. Robertson had invited Reno and his friends when they were students for a special lunch to meet them and provide them with any support they may have needed. Reno

never forgot this kindness and wanted to do something special for generations of students for years to come. His scholarship will be launched in 2025 and will also be offered in perpetuity.

Alex Davidson's successful career in the mining industry during the past 25 years has taken him worldwide. His expertise in designing, implementing, and managing gold and base metal exploration, as well as acquisition programs throughout the world, has yielded many rewards. In 2005, Mr. Davidson was presented the A.O. Dufresne Award by the Canadian Institute of Mining, Metallurgy and Petroleum to recognize exceptional achievement and distinguished contributions to mining exploration in Canada. In 2003, Mr. Davidson was named the Prospector of

the Year by the Prospectors and Developers Association of Canada in recognition of his team's discovery of the Lagunas Norte Project in the Alto Chicama District in Peru and, in 2023, Mr. Davidson was inducted into the Mining Hall of Fame. Mr. Davidson is also a Director of Capital Limited Company, and Chairman of Americas Gold and Silver. He continues to provide his leadership to benefit members of the mining industry and the companies he continues to serve. In 2022, Alex and his wife, Gillian, created their family endowment in perpetuity for the benefit of Indigenous students seeking a career in one of the many facets of the mining industry. Dear Members of the Dr. David Robertson Family,

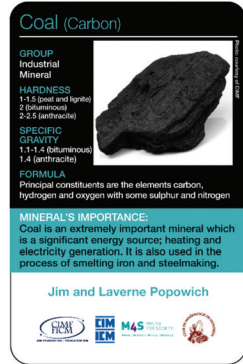

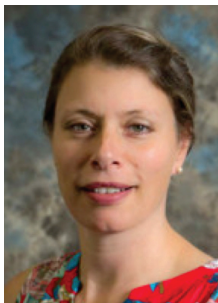
The creation of the Alex and Gillian Davidson Endowment was the beginning of a new culture of support for Indigenous students. Even though the Canadian government provides funding for studies, many Indigenous students must travel far away from home and their family and friends - their support group - to receive a secondary, college and/or university education. The funds that this endowment provides allow for necessary extras, such as a cell phone service to call home, occasional travel back to their communities, and any incidentals that will help keep these students motivated to stay in school and succeed in their studies. The term scholarship has been changed to a grant to remove any sense of competition for the funds. The Taking Flight Grants have been offered since 2010 with the much-needed Davidson Endowment provided to the CIM Foundation in 2022. The grants have yielded excellent results: to date, every qualifying applicant has received support, but the demand is increasing twofold and will require additional support from generous benefactors.

The Taking Flight Grants program provides three \$4,000 grants to Indigenous students annually. Its endowment is carefully invested, and the capital will remain intact ensuring support in perpetuity. In the Fall of 2023, the CIM Foundation received more applicants and began searching for additional support to provide grants to all these Indigenous students, as students tend not to reapply if they are turned down due to a lack of funds.

In the Fall of 2023, three donors stepped up to contribute to this important program and covered the grants for all the additional students who submitted excellent applications.

As this program continues to attract increasing numbers of Indigenous students, additional funds are required to continue to support all qualifying applicants. PROFILE OF ADÉLINE BASILE, RECIPIENT OF A 2020 TAKING FLIGHT GRANT



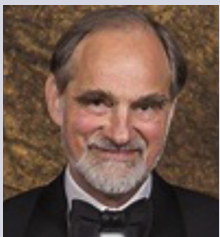

Adéline Basile, a valued community leader and a grandmother, is studying Law at the University of Ottawa. She is an Innu from Mingan at the mouth of the Mingan River on the North Shore of the Gulf of the Saint Lawrence in Quebec. She is a member of the Ekunaitshit band, a community of 690 members that were founded prior to 1630 when their ancestors

were first noted on a map. Their reserve has mining interests with Rio Tinto. In 2023, Adéline was asked by her community members to help lead Mingan in the discussions regarding the community's development. In 2020, when she applied for a Foundation grant, she had noted her concerns about the quality of water and housing conditions within her community. Adéline agreed to take a sabbatical from her studies to support the community's Chief during these important developments. She plans to finish her third year of studies and graduate as a lawyer able to further contribute to her community's well-being.
